1. The Chairman welcomed those present.

#### Apologies for Absence

Action

2. The secretary reported that the committee had received apologies for absence from Col Strong, Fg Off Niblock, Cpl Vaughton and Cpl Malmstrom.

#### Minutes of Last Meeting

3. The minutes of the last meeting were read and accepted as a true record of the meeting.

Proposed: Sgt Sumpter Seconded: Cpl Thomas Carried unanimously

#### Matters arising from the Previous Minutes

4. Para 23 of the last minutes; It was understood that Wg Cdr Clark was still progressing the offer of Honorary Life Membership to Steve Jones. Mr Lewins stated that he would take up the matter and ensure it was resolved by the next AGM.

- 5. Para 25 of the last minutes; The posters had been purchased and appear to have been highly effective, however the initial purchase had all but been used up. The Hon Sec proposed that a further £20 be voted to purchase another batch.
- 6. Para 30 of the last minutes; The Hon Sec had investigated the reprinting of the Club Constitution and Rules. He felt that some 400 could be reprinted for around £100 but this would mean a slow self help job by the Hon Sec. In that the covers would be printed commercially but the inside would be typed and photo-copied.
- 7. Mr Lewins then stated that his company would meet 30%

of the cost of the covers in exxhange for an advert on the inside. The Hon Sec then offered to meet another 30% of the cost for the same conditions

- 8. The following proposal was put to the meeting:
  - a. That £20 be allocated to reprint the publicity poster.
  - b. That the sum of £100 be allocated to reprinting the Club Constitution and Rules.
  - c. That the offers of Mr Lewins and the Hon Sec be accepted.

- 9. The Chairman informed the meeting that due to pressure of work and his continued absence in Northérn Ireland he was tendering his resignation as Chairman. Lt Col Howard had been asked by the committee to take on the Chairmanship of the Club and had agreed so to do.
- 10. The Secretary pointed out that he was still due to leave the RAF in January 1987 and felt that he should not continue as Hon Secretary after that date as the Secretary should always be a serving member of the services. However he would continue to carry out the duties until a suitable volunteer was found.
- 11. There were no other candidates for chairman therefore Lt Col Howard was asked to chair the remainder of the AGM.

Proposed: Flt Lt Gilroy Seconded: Sgt Morrall Carried unanimously.

- 12. The Club President then formally proposed a vote of thanks to Lt Col Ling for his hard work over the previous years. The vote was carried unanimously.
- 13. With the discovery of the Club archives the meeting felt that the Club should have a Historian to maintain and update the Club History. This post would be an ex-committee one and would thus not require ratification at an AGM. F/S Morris volunteered to take on this task and now has custody of the Clubs History.

#### Financial Report

16. The Treasurer presented the balance sheet to the meeting, copy attached, and reported that the club was financially sound.

- 17. Auditing of the Clubs accounts had once again been carried out by the RAPC and this arrangement should continue for the foreseeable future.
- 18. The accounts were accepted as a true record of the Clubs financial position.

#### Presentation of Trophies

19. The Club President presented the 1985/86 Cross Country Trophy (an engraved glass goblet) to Cpl Eric Thomas. Mr Lewins told the meeting that as yet he had been unable to determine the winner of the Marathon Trophy as no club members had approached him at Swinderby.

- 14. The Secretary reported that he was continuing to produce Milonews mainly by scrounging good quality photocopying facilities and therefore the cost to the Club was zero. However he wished once again to have £100 allocated towards the cost of producing the newsletter.
- 15. Once again Mr Lewins stated that his company was prepared to meet up to £50 of the cost of producing the newsletter.

#### Unit Membership

- 16. The Hon Sec informed the meeting that he had received a letter from Lt Col Kenway, Commanding 1st Battalion The Duke Of Edinburghs Royal Regiment, asking if the Club could offer unit membership. The matter had discussed with the SCAA who had advised the Committee that under the terms of our constitution which defines the Club as a "club" in which case membership must be on an individual basis.
- 17. Some discussion then took place on whether the club should be redefined as an "association" which would get round the unit mebership problem. However it was obvious from the tone of the discussions that the Clubs traditions and history sre to great to permit such a radical change.

#### Recruitment and Publicity

18. Flt Lt Gilroy reported that recruitment of new members was proceeding very nicely within the RAF and Northern Ireland units of the Army. However new members from the Army within the UK were few and far between and non existant from the RN. The Chairman promised the meeting that he and the Hon Sec would try to rectify this problem.

20. Mr Lewins stated that as his yearly report had been published in the last issue of Milonews he did not propose to go through it again. However he had found the results that had been misplaced and luckily they had made no difference to the club championship. The Chairman then thanked him for his enthousiasm and services over the past year.

#### Any Other Business

21. Germany Grant. Cpl Eric Thomas, who had volunteered to organise the Germany Trip this year, proposed that a grant of up to £120 be voted to offset the cost of the teams travel to Germany for the fixture against 13 Sig Regt.

22. Presentation to 13th Sig Regt It was suggested from the floor that some sort of presentation should be made by the club to thank 13th Sig Regt for their hospitality. F/S Fiddes suggested that the first man home from the 13th Sig Regt Team should be given a similar engraved goblet to that presented as Trophies earlier in the AGM. This idea was accepted as a firm proposal.
