The Chairman welcomed those present and passed on the 1. Presidents apologies; he was currently in Australia.

Apologies for Absence

The Secretary reported that he had received some 14 apologies for absence.

Minutes of Last Meeting

The Secretary stated that the minutes of the last meeting had been published in the November 1986 issue of the Milonews and proposed that they be accepted as a true record of the meeting.

Seconded: Mr Lewins Carried unanimously

Matters Arising from the Previous Minutes

- Sgt Morris, the Club Historian, was progressing with the Club's History but there was a large gap in the records for the period 1956-77. The Secretary was asked to publisice this in Milonews in the hope that someone knows where the missing records are.
- The Milonews continued to be published successfully. Mr Gilroy and Mr Lewins stated that they would, once again, pay the printing costs of one issue each.
- The post of Treasurer has been taken on by Mr John McCarthy for which he was thanked by the Chairman.

Financial Report

- 7. The Treasurer presented the balance sheet for 1986 to the meeting, copy attached, and reported that the club was financially sound. The accounts had once again been audited by the RAPC, however Mr McCarthy stated he would try to find someone more convenient to audit them.
- 8. The Chairman thanked Gp. Capt. Pierce for his valuable services as Treasurer.
- 9. The Accounts were accepted as a true record of the Clubs financial position.

Committee Members

- 10. The Secretary stated that, as Mr Gilroy is no longer Serving, the Committee required an RAF Member. Sgt Andy Law was asked to take on this job to which he agreed.
- 11. The positions of Army and Navy Members were still vacant and the Chairman stated he was pursuing the matter.
- 12. The Chairman then proposed that Mr McCarthy and Sgt Law be elected to the Committee as Treasurer and RAF Member respectively.

Seconded: Hon Secretary Carried unanimously

Cross Country Secretary Report

- 13. Mr Lewins told the meeting that his report had already appeared in Milonews and summarised the salient points.
- 14. Two other fixtures for this season were being arranged with Thames Hare and Hounds and the Metropolitan Police. The Birgelen fixture was still in the air and was being progressed by the Chairman and it was hoped to arrange it before Christmas came along. If no fixture could be arranged some thought would be given to trying some other venue in Germany.
- 15. Cpl Eric Thomas was thanked by the Chairman for his efforts in organising last years Germany trip. Cpl Thomas agreed to organise this seasons trip once details were confirmed.

Presentation of Trophies

- 16. The Chairman presented Cpl Eric Thomas with his Trophy for winning the Club Cross Country Championship for 1986/87.
- 17. The Marathon Trophy for 1986 had been won by Sgt Gary Mitchell of CIO Leicester. The results from this years Swinderby Marathon were still awaited.

Hon Secretary's Report

- 18. The Hon Secretary informed the meeting that new Club Posters had been produced and were being distributed. Also, through the good auspices of Sgt Mike Sumpter, the constitution was being reprinted and would, hopefully, be distributed within the next few months.
- 19. A general tightening up in the military postal services meant that the Club was no longer able to use these channels and as a result postal charges would figure in the Club's budget. Consequently members mail would gradually be sent to them via their banks. This would also reduce the likelihood of losing track of members as they are posted.

Any Other Business

20. Mr Lewins stated that the new club vest had been ordered and all of the first batch had been sold. They had not, unfortunately, been delivered in time for the pre-AGM fixture. The vests cost nine Pounds each and Mr Lewins proposed that the Club subsidise this by four Pounds per vest. The Treasurer asked that the proposal be amended to state that the amount of subsidy should be reviewed annually.

Seconded: Cpl Thomas Carried unanimously

21. The Hon Secretary stated that as the vests figured the Club name in a prominent fashion it was in the Clubs interest to ensure that members bought and wore them. He therefore proposed that the initial subscription should be ten Pounds to cover the provision of a Club vest as well as the first years membership. Membership should stay at Five Pounds for subsequent years.

22. There was a stock of 5 old vests on the club's books and the Treasurer proposed that these be written off.

Road Running

- 22. Sgts B O'Reilly and P Lawrence expressed an interest in promoting road running in the Club by entering teams in selected events and said they were prepared to organise this.
- 23. Mr Lewins proposed that several road races be selected as club events and that the club would meet travel expenses but not entry fees.

24. There being no further business the Chairman declared the meeting to be closed at 1755 hrs.
